

## Psalms Reading And Studying The Book Of Praises

A Word Fitly Spoken explores significant poetic devices within the four alphabetic acrostic psalms found in Book I of the Psalter. The majority of scholarly opinion has been that these acrostics are poetically and artistically deficient due to the writers' and editors' preoccupation with the alphabetic pattern. In contrast to this view, A Word Fitly Spoken proposes that the acrostic pattern contributes to, rather than detracts from, the poetic artistry of these psalms. In an effort to promote a holistic, canonical reading of the four acrostic poems within Book I of the Psalter, this study also examines the linguistic and grammatical connections within the text. Such a close reading repeatedly demonstrates the emotive power and the imagination of this literature in contradiction to its supposedly stiff, wooden nature. A Word Fitly Spoken is attuned to the frequent plays on word and sound that occur throughout these four poems and as such would be useful in graduate courses on biblical interpretation, Hebrew poetry, or the Psalms.

In *A Story of the Psalms*, V. *Introduction to the Psalms: A Song from Ancient Israel* seeks to provide the reader with a solid introduction to the Hebrew Psalter, one that is informed by an interest in its shape and shaping. The author, Nancy deClaiss-Walford, provides an up-to-date study on the poetic style of the psalms in the Psalter, their Gattungen or genres, the broad shape of the book, and the history of its shaping. She introduces each of the five books of the Psalter, providing a detailed examination of those individual psalms that are either key to the shaping of the Psalter or interesting studies in poetic style. In the final chapter, deClaiss-Walford draws conclusions about the shape of the Psalter and about its story and message. She proposes a way to read the Psalms as a unified whole and in relationship to one another rather than as individual pieces, giving an inclusive, all-encompassing shape to the Psalter. Included are two appendices that provide a listing of the superscriptions and Gattungen of the psalms in the Hebrew Psalter and an explanation of many of the technical terms found in their superscriptions.

This book examines literary conventions in the psalms of communal lament and their reflection and modification in post-exilic penitential prayers. It analyzes elements of shared form and demonstrates the literary relationship between these psalms and prayers.

In this monumental work, his most ambitious undertaking, the late Samuel Terrien brings together a lifetime of scholarship on Psalms, long the wellspring of Jewish spirituality as well as the main hymnal of the Christian church. While Terrien always engages in scientific exegesis before drawing theological conclusions, he is careful to allow full expression to the theological -- and, especially, the doxological -- voice of these unmatched spiritual songs. The result is a commentary that provides a link between the archaic language of Psalms and the intellectual demands of modern thinking and spirituality. Throughout his exposition Terrien shows great respect for the scribal testimony of the Jewish tradition, especially the consonants of the Masoretic text. He likewise displays great care in finding the most accurate meaning for Hebrew words of obscure origin. This meticulous work renders a translation of Psalms more reliable than those of Terrien's predecessors. He also draws on many fruitful gains of structural analysis in discerning the strophic divisions within the Hebrew text. Often he finds unity of composition where earlier critics denied it. And for readers interested in specific aspects of translation and interpretation, Terrien has appended bibliographical lists of modern works on each psalm.

General editor Lloyd J. Ogilvie brings together a team of skilled and exceptional communicators to blend sound scholarship with life-related illustrations. The design for the Preacher's Commentary gives the reader an overall outline of each book of the Bible. Following the introduction, which reveals the author's approach and salient background on the book, each chapter of the commentary provides the Scripture to be expounded. The recommended method for using this commentary (and volume 21) is 1) read the text of the psalm before studying the commentary; 2) after reading Sections I and II of the commentary, reread the text of the psalm in the light of its biblical origins; 3) after reading Section III of the commentary for each psalm, reread the psalm in the light of its key words and phrases; and 4) after reading Section IV of the commentary, reread the psalm prayerfully once more.

Read both of the last two bullet points in the Biblical Basis section. What does discernment mean and how does it look today? This text introduces the book of Psalms and provides an exposition of each psalm with attention to genre, liturgical connections, societal issues and the psalm's place in the book of Psalms as a whole. The treatments of the psalms feature a close look at particular issues raised by the text and the encounters between the world of the psalm and the world of contemporary readers. The exposition of each psalm provides a reader's guide to the text in conversation with relevant theological issues.

A reader-oriented approach provides a substantially new angle of vision on Psalm 18 and Psalms study in general. Reader-based interpretation is compared to conventional methodologies by means of four separate analyses of Psalm 18: a textual study, a form-critical explication, a rhetorical study, and an experimental reader-oriented study involving the following strategies. Initially, the components of the text are considered as networks of signals for the reader. Secondly, the text's speech acts are isolated and typified. Thirdly, the ancient and contemporary contexts for the reading of the psalm are examined. The reader-oriented study culminates in two perspectives upon Psalm 18. The psalm may be read as a ritual speech act performed by the community of ancient worshippers, or as a lyric poem that each contemporary reader experiences by identification with the speaker. The concluding chapter reviews each of the methodologies, evaluating strengths and weaknesses, as well as interrelationships among methods.

A cursory glance through the Psalter reveals numerous allusions to events in Israel's literary history. While a range of literary and oral sources were obviously available to psalmists, the relationships between these sources and the psalmists' final work are more obscure. Concerning these relationships, numerous questions remain unanswered: - How strictly did the psalmists replicate their sources? - What kinds of alterations did they make (additions, omissions, etc.)? - Did they alter the meaning of their sources in their own compositions? Departing from the more classical approaches to researching the psalms--engaging in the determination of Sitz im Leben and Gattungen--this intertextual study addresses the aforementioned issues by focusing on a group of psalms associated with Israel's exodus tradition (105, 106, 135, and 136). Through a detailed comparison of lexical correspondences between the psalms and other biblical texts, together with a relative dating of each psalm, the study identifies literary sources employed by the psalmists. It additionally includes a close reading of each psalm to establish the unity and meaning of each composition. Emanuel then analyzes and categorizes lexical variances between each psalm and its sources, providing potential explanations for alterations found between the two, and revealing how the psalmists reinterpreted their biblical sources.

The author's discussion of Crow tribal history and his vivid descriptions of current reservation life show how the Apsáalooke are adapting to a changing world. By examining pivotal social and religious institutions, including the clan-uncle and clan-aunt relationships, the acquisition and use of medicine, and the Sun Dance, the author show how reciprocity and interdependence weave together Apsáalooke society and help individuals determine their place in clan, society, and cosmos.
